

SELLER AGREEMENT -----

Consignment Terms

For sellers consigning items to Collect DXB

Version 1.1 · Last updated: June 2026

These Terms apply when you consign an item to Collect DXB — that is, you appoint us to sell it on your behalf for a commission. If you would prefer us to buy the item from you outright, our separate Sell to Us — Purchase Agreement applies instead.

01 About Collect DXB

“Collect DXB” is the brand and trading style of a Dubai-licensed establishment registered with the Department of Economy and Tourism (DET) under Trader Licence no. 1616389, registered trade name “Collect Luxury Items Online Seller” (in these terms, “Collect DXB”, “we”, “us”, “our”). We source, authenticate and resell vintage and pre-owned luxury goods, including wristwatches, Hermès and other designer handbags and accessories, jewellery and collectibles. We operate online via collectdxb.com; items are sent and received by insured courier or by prior appointment. Contact: info@collectdxb.com.

02 Your warranties

You warrant that each item you deliver to us is genuine and authentic, lawfully owned by you and free of any charge, lien or third-party claim, that you are entitled to sell it, and that all information you give us about it is true, complete and accurate. These warranties are fundamental to this agreement.

03 Restoration and prior work

You must tell us, before delivery, of any restoration, service, repair, refinishing, re-dyeing, polishing, part replacement or other work you know or reasonably suspect has been carried out on the item, whether by you or a previous owner, together with any accompanying documentation. This helps us describe the item accurately to a buyer. Disclosed restoration or service work does not, by itself, prevent us from accepting or listing an item — many vintage pieces have been sympathetically restored — but restoration or replaced parts that you knew of and did not disclose, and that materially affect the item’s value or saleability, are a breach of your warranties and may entitle us to adjust the agreed pricing, withdraw the item from sale, unwind a completed sale, or recover any resulting loss under the indemnity below.

04 Authentication and counterfeit items

We authenticate every item before we list, sell or buy it, and you are solely responsible for ensuring that the items you send us are genuine. If an item is found to be counterfeit, replica or otherwise not authentic at any time: (a) we will not list or sell it and, if a sale has completed, we will reverse it; (b) you must immediately reimburse us in full for any amount already paid to you and for all costs we incur, including the cost of unwinding a completed sale and any refund to a buyer; (c) a counterfeit-handling

fee applies per item, excluding shipping, of AED 5,000 for Hermès, Chanel, watches and jewellery, and AED 1,000 for all other brands, which the parties agree is a genuine pre-estimate of our administrative and reputational costs; in addition we may recover our actual costs and losses to the extent they exceed that amount; and (d) we are not obliged to return a counterfeit item and may withhold, surrender or dispose of it as required by law, at your cost. Dealing in counterfeit goods is unlawful; we may report suspected counterfeiting to the relevant authorities.

05 Identity and source of funds (AML)

As a dealer in luxury goods, precious metals and stones, we are subject to UAE anti-money-laundering law. Before we pay you, you authorise us to verify your identity and, where required, your source of funds or title to the item, and to keep and report this information to the authorities where the law requires. We may delay or decline a transaction to meet these obligations.

06 Verification

To confirm authenticity, you authorise us to inspect each item and, where necessary, to submit it to the relevant manufacturer or an independent authority for verification. You agree to provide any documentation, provenance or proof of purchase we reasonably request, and authorise us to share relevant provenance with a buyer or competent authority where necessary to complete or substantiate a sale.

07 Indemnity

You agree to indemnify and hold Collect DXB harmless against all losses, claims, demands, costs, expenses, fines and penalties (including reasonable legal costs) arising from any item you deliver to us being counterfeit, mis-described, unlawfully held or subject to a third-party claim, or from any breach of your warranties or these Terms. This obligation continues after an item is sold or returned and after these Terms end.

08 Exotic and protected materials

If an item is made from exotic or protected animal materials (for example crocodile or alligator skin), you must tell us before delivery. You warrant that it was lawfully acquired and is lawfully held, and you must provide any species or CITES documentation you hold. Such items will not be listed until any required UAE (MOCCAE) registration and species identification are complete, and may only be sold for delivery or collection within the UAE unless cross-border shipment can lawfully be arranged.

09 Condition and handling

We handle items with care, but pre-owned leather and metal may acquire minor handling marks, and natural materials may change over time. Collect DXB is not liable for ordinary handling marks or natural changes of this kind. Please remove all personal belongings from any bag, box or pouch before handing it to us; we are not responsible for personal effects left inside items.

10 Appointment and process

By consigning an item, you appoint Collect DXB as your exclusive agent to market and sell it during the Consignment Period. We photograph, describe, price (by agreement with you) and list the item on

collectdxb.com and/or offer it by private sale. We determine the listing presentation and sales process, and list items on a first-in, first-out basis where practicable.

11 Commission

On a successful sale, the net sale proceeds — the final sale price actually received, less payment-processing charges and any shipping cost — are shared between you and Collect DXB according to the schedule below:

Final sale price (AED)	You receive	Collect DXB commission
Up to 5,000	70%	30%
5,001 – 25,000	75%	25%
25,001 – 100,000	80%	20%
100,001 and above	85%	15%

12 Listing period and pricing

The listing period is 90 days from the date the item is first listed (the “Consignment Period”), renewing automatically for further 30-day periods unless either party gives notice. The sale price is set by agreement at intake. We may, after discussing it with you, adjust pricing to reflect market conditions, but we will not sell below an agreed floor price without your consent.

13 Settlement

Following a completed and cleared sale, and once any applicable buyer return window has passed, we settle your share by bank transfer to your nominated account within 14 Working Days. You are responsible for providing accurate bank details and for any bank charges.

14 Withdrawal and return

Title to a consigned item remains with you until it is sold to a buyer, at which point title passes from you to the buyer on completion. If you wish to withdraw your item before the 90-day Consignment Period has ended, you must give us at least ten (10) days’ written notice and pay an early-withdrawal fee of AED 1,000, which the parties agree is a genuine pre-estimate of our intake, photography, listing and marketing costs. We will arrange the item’s return by insured carrier once the notice period has expired and the fee has been paid. You may withdraw the item at the end of the Consignment Period, or at the end of any renewal period, on notice and without the early-withdrawal fee. Return shipping and any other agreed costs incurred are payable by you.

15 Governing law

These Terms are governed by the laws of the UAE as applied in Dubai, and the parties submit to the jurisdiction of the Courts of Dubai. Contact: info@collectdxb.com.
